MUNICIPAL ELECTIONS ACT, 1996, S.O. 1996, c. 32**

TOWN OF NIAGARA-ON-THE-LAKE 2010 MUNICIPAL ELECTION  
MONDAY OCTOBER 25, 2010

Nominations will be accepted for the offices of:

**Lord Mayor - Councillor - Regional Councillor**

Nominations, in the prescribed form, may be filed in the Office of the Town Clerk, 1593 Four Mile Creek Road, Virgil, in person or by an agent, during regular business hours (Monday to Friday, 8:30 a.m. - 4:30 p.m.) until September 9, 2010, and on Nomination Day, September 10, 2010, between the hours of 9:00 a.m. – 2:00 p.m. The term of elected office will be from December 1, 2010 to November 30, 2014.

Under Section 29(1) of the Municipal Elections Act – “A person may be nominated for an office only if, as of the day the person is nominated:

- a) he or she is qualified to hold that office under the Act that creates it; and,
- b) he or she is not ineligible under this or any other Act or otherwise prohibited by-law to be nominated for or to hold the office.”

The following must be provided at the time of submission:

- A Nomination form (to be signed in the presence of the Clerk, etc.)
- A Declaration of Qualification form (to be signed in the presence of the Clerk, etc.)
- The prescribed filing fee of \$200.00 for the Head of Council and \$100.00 for all other offices (The filing fee is payable by cash, debit, or certified cheque or money order)
- Candidate identification (Government issued photo identification).

Nominations for:

**District School Board of Niagara Trustee - French Language Separate School Board Trustee** may be made by completing and filing nominations in the prescribed form in the office of the Clerk, City Hall, St. Catharines.

**Niagara Catholic District School Board Trustee** may be made by completing and filing nominations in the prescribed form in the office of the Clerk, City Hall, Niagara Falls.

**French Language Public School Board Trustee** may be made by completing and filing nominations in the prescribed form in the office of the Clerk, City Hall, Hamilton.

Nomination and Declaration of Qualification forms are available at the Clerk’s Department and [www.notl.org](http://www.notl.org)

In the event there are an insufficient numbers of certified candidates to fill all positions available, nominations will be reopened for the vacant positions only on Wednesday, September 15, 2010 between the hours of 9:00 a.m. and 2:00 p.m. and such additional nominations, if required, may be filed in the office of the Clerk.

A Candidate Information Session is being held on April 28, 2010, from 7:00 p.m. to 9:00 p.m., at the MacBain Community Centre – 2<sup>nd</sup> Floor, 7150 Montrose Road, Niagara Falls for anyone interested in running for municipal office (this is not a candidate debate forum).
