**Describe your Drinking-Water System**

The Bevan Heights Distribution System is a small municipal residential system servicing 63 customers. Water is received from a City of Niagara Falls distribution main which is supplied from Region of Niagara transmission main. The original water system here dates to the 1950's. All watermains, appurtenances and service lines within the subdivision were renewed in 2002. The lone exception is on Mallette Crescent where the watermain dates to 1971 and is still adequate. Service lines on Mallette Crescent were renewed in 2002. There are approximately 10 fire hydrants and 15 line valves on the system.
